Your register of deeds, Lynn's John O'Brien, has been in the forefront of efforts to expose a scheme by banking industry giants to evade the normal mortgage filing requirements via something called the Mortgage Electronic Registration System. The alleged improprieties have stopped many foreclosures in their tracks and are the subject of investigations being launched by Martha Coakley and her fellow attorneys general nationwide.

O'Brien was featured in an NBC News report this week in which he complained that the banks are not playing by the same rules, or paying the same fees, that apply to the average person who walks into the Registry office in Salem.

Meanwhile, O'Brien's colleague at the northern end of the county, was also on TV recently. Robert Kelley was featured in a Fox News piece that was not nearly as complimentary.
